Clearance (taken within six-months of hire).

I also understand that prior to employment, I must submit the following DHS requirements: 1) Employment History Check(s) to verify my previous employments and work performances; and 2) A Criminal History Check.

I also declare that I have not been in the past, nor am in the present, nor will be in the future involved in any circumstances which would have the potential to pose a danger to the staff's and/or children's health, safety, and well-being.

I hereby authorize the administrator(s) of Makakilo Baptist Church Preschool to investigate all information contained in my employment application and for all persons and/or agencies named in my application to furnish any information requested by Makakilo Baptist Church Preschool or its administrator upon their request.
